FINANCIAL INFORMATION - COLLEGE FEES AND CHARGES

ACCEPTANCE DEPOSIT

- A deposit of \$200.00 is payable upon acceptance of an offer at the College.
- The \$200.00 deposit is credited against 1st Term Residential Fees or Day Student Fees.
- The Acceptance Deposit is fully refunded in the event of a written withdrawal being received prior to the commencement of Term 1.

YEAR 10, 11 & 12 COSTS

These fees include:

- Subject Costs
- Compulsory course charges and other services provided by the College, which are not directly part of the educational program.

Full details of these costs are included in this booklet and are to be paid on enrolment day at the College.

RESIDENTIAL BOARDING FEES

The Corporate Executive of the Department of Education determines Residential Boarding Fees at Agricultural Schools and Colleges. The residential status of students is conditional on the payment of this fee

Boarding fee instalments are to be paid prior to the *first day of each term* to which they relate unless a prior arrangement has been approved by the Principal. The Principal may refuse permission for a student to take up residence if any fees and charges are outstanding.

All fees need to be paid in full BEFORE the commencement of Term 4.

DAY STUDENT MEAL CHARGES

This charge is for the supply of morning tea and lunch supplied to Day Students on a daily basis. This amount is cost recovery of the food component only. The annual fee is \$910.00 which is payable in two instalments (1st day of each semester).

RESIDENTIAL EXCURSION COSTS

An amount has been charged for Residential Excursions. This sum of money will be used throughout the year for student excursions (eg: Busselton Camp, Zoo trip etc). At the end of the year any unused portion will be refunded to parents or carried forward to the following year. This eliminates the need for students to carry cash at school for such events.

TRADES PERSONAL PROJECT COSTS

All Metals and Engineering and Furnishing students are required to make a personal project. Students are required to meet the costs of their personal projects. Past costs of these have ranged from \$10 - \$10 000 relative to the scale and complexity of the project. The students, in consultation with the parents and teachers, will be required to prepare a costing for their approved project. 50% payment of this cost will then be required to be made prior to the ordering of materials. If any changes are made from the initial quotation, parents will need to approve the price variation for work to continue.

SAFETY EQUIPMENT

All new students are issued with PPE in their Tradie Bag when they commence at the College. Replacement items for Farm and trades will be charged when replaced.

All safety equipment items listed below are required and available from the College. However, you may wish to purchase them elsewhere. Students require these for the entire time whilst at the College.

If there is a loss or damage to these, the full cost recovery will apply. Ownership of these items will be checked at the end of each year and charges will be applied accordingly.

STUDENT DAMAGE TO COLLEGE PROPERTY

If a student maliciously damages College property, they will be required to pay for the cost of repair or replacement.

There is a financial cost of \$1077 for any student involved or found to have instigated a FALSE ALARM.

REFUND POLICY

REFUND RESIDENTIAL BOARDING FEES

If a student leaves the College through their own choice or through termination of residency, fees remain payable for the number of weeks the student has been in residence. Parents will be refunded the excess if applicable on a pro rata basis.

REFUND COLLEGE CHARGES

If a student ceases the educational program at the College, pro rata of Charges less the percentage of any Government Subsidy, will be refunded to parents according to the time of the year. This is calculated on a pro rata basis and is consistent with the Department of Education Fees Policies

NO REFUND of fees is payable for any period of short term absence by a students from the College. Fee refunds for long term absences should be negotiated with the Principal.

FINANCIAL ASSISTANCE

BOARDING FROM HOME ALLOWANCE – SPECIAL SUBSIDY

This subsidy is not available to students who are in receipt of the following:

- Assistance for Isolated Children (AIC)
- Youth Allowance at the Away From Home Rate
- Abstudy with full boarding paid by Centrelink

Application forms will be available on enrolment day, parents need to complete and return to the College.

SECONDARY ASSISTANCE SCHEME

The Department of Education provides an allowance to assist eligible families with secondary schooling costs. To be eligible for the allowance the parent/guardian must hold a Centrelink Family Health Care Card, Centrelink Pensioner Concession Card or a Veterans' Affairs Pensioner Concession Card.

PLEASE NOTE: The only Veterans' Affairs Card that meets the criteria is a blue card that is issued each year and expires in December each year.

The allowance consists of two components:

- \$115 Clothing Allowance which can be paid to the college or parent/guardian
- \$235 Education Program Allowance which is paid directly to the College and will be deducted from contributions and course charges.

Application forms are completed at the College in Term 1 each year with the closing date being the last day of term ie 1st April 2023.

ASSISTANCE FOR ISOLATED CHILDREN (AIC)

AIC aims to assist the families of primary, secondary and under 16 year old tertiary students who are unable to attend an appropriate government school on a daily basis because of geographic isolation.

An appropriate government school is one which offers the student's level of study or, if the student has special healthrelated or educational needs, one which provides access to the facilities, programmes and-or environment required for those needs.

A student may be regarded as geographically isolated from appropriate schooling if one of the following rules are met:

Rule 1 – The distance between the principal family home and the nearest appropriate state school is at least 56 kilometres via the shortest practicable route, or

Rule 2 – The distance between the principal family home and the nearest appropriate state school (via the shortest practicable route) is at least 16 kilometre AND the distance between the principal family home and the nearest available transport service to the nearest appropriate state school is at least 4.5 kilometres via the shortest practicable route.

Rule 3 – If Geographic Isolation Rules 1 or 2 do not apply but there are other circumstances that make it impracticable for the student to travel between the family home and the nearest state school on at least 20 school days of the year then Geographic Isolation Rule 3 may apply. Evidence must be provided.

STATEMENT OF BOARDING

- 1. The parent(s) or guardian(s) must pay the College the Residential Boarding Fees as determined by the Department of Education in accordance with timelines set by the College.
- 2. Residential boarding fees must be paid prior to the first day of the term to which they relate, unless a prior arrangement has been approved by the Principal. The Principal may refuse permission for a student to take up residence if any fees are outstanding or if there is no negotiated payment plan in place.
- 3. No refund of fees is payable for any period of short term absence by a student from the College. Fee refunds for long term absences should be negotiated with the Principal.
- 4. The College reserves the right to discipline, suspend or exclude a student from residence if the student's behaviour is: (a) in the Principal's sole discretion, unacceptable; or (b) in breach of the College's rules and regulations and any code of behaviour.
- 5. The parent(s) or guardian(s) are liable for any damage to the College or residence caused by a negligent, reckless or wilful act of a student.
- 6. The College is responsible for the safety and welfare of students while under its care and control, but it is not liable for any illness, injury or death unless it was caused by the negligence of the College. The College is not responsible for injury or death resulting from an accident.
- 7. A student is responsible for their own property and any loss or damage to that property, unless it was negligently caused by the College.
- 8. The parent(s) or guardian(s) must ensure the punctual arrival and departure of the student at the start and finish of any period of leave.
- 9. The student must abide by the College's rules and regulations and any code of behaviour as amended from time to time.
- 10. In order to ensure the safety and well-being of the student and other students at the College, it is expected that the Principal is advised of any serious medical conditions and/or social or emotional issues that may impact on the student's life at the College.
- 11. To assist the College to respond to a student's individual needs, it is recommended that the Principal is advised of any specific learning issues or of any services, which the student receives from external agencies.
